

Task Force Name – Employment and Training Task Force

Top Legislative/Regulatory Issues – The Employment and Training Task Force (E&TTF) has spent 2018 working to build consensus and to make the views of its constituent members known on critical issues around advancing employment opportunities for people with disabilities.

#1 WIOA Regulatory Issues – A crucial and controversial issue among our Task Force members is the perennial but unrealized threat by the Department of Education to revisit, reopen and tamper with the regulations associated with the Workforce Innovation and Opportunity Act (WIOA). As with any substantive law, there have been implementation issues, especially around RSA's interpretation and guidance, that have affected Task Force members and our state affiliates. However, a working group met multiple times to develop a <u>compromise document</u> reflecting a stronger consensus of our members. Did all Task Force members endorse the final document? No. However, the dialogue directly advanced our collective work. Thus far, despite multiple notices in the Unified Agenda, Education has yet to open the WIOA regs.

#2 Disability Employment Incentive Act (DEIA) of 2018 – Given the uncertainty of the mid-term elections, our Task Force was glad to see the continuing leadership of Sen. Bob Casey. At the end of July 2018, Sen. Casey introduced the Disability Employment Incentive Act (DEIA). This proposed legislation is "designed to encourage employers to hire and retain employees with disabilities" by enhancing the Work Opportunity, Disability Access Expenditures, and Architectural and Transportation Barrier Tax Credits. While this proposal gained little legislative traction in the final months of the 115th Congress, the bill accords with stated TF priorities and we are eager to see it advance in the new year.

#3 Comments on Federal Disability Employment/Regulatory Issues – In February, the E&TTF joined with our colleagues from the Social Security Task Force to <u>submit public comments</u> in response to a Request for Information Regarding Strategies to Improve Adult Outcomes for Youth Receiving Supplemental Security Income, published on January 3, 2018 [Docket No. SSA–2017–0049]. Key recommendations included Transition and Postsecondary Programs, supporting work-based learning, codifying the rules regarding continuing disability reviews (CDRs) as well as data sharing with VR and education programs.

The Task Force also <u>wrote and submitted a letter</u> to the Secretary of Labor to express our concern about an Executive Order issued by the President entitled "Reducing Poverty in America by Promoting Opportunity and Economic Mobility." The letter directly addresses the challenges involved with punitive work requirements on people receiving various federal benefits programs. Likewise, the Task Force <u>wrote a detailed letter</u> with clear recommendations to the Equal Employment Opportunity Commission (EEOC) in order to develop guidance concerning the treatment of service animals in the workplace. Lastly, E&TTF joined our colleagues on the Veterans Task Force to submit public comments on the information collection notice issued by OFCCP regarding 503 and VEVRAA.
