Dear Senator Casey:

On behalf of the Education Taskforce of the Consortium of Citizens with Disabilities (CCD) which represents the nearly six million students with disabilities who receive special education services across the country, we write to extend our most sincere appreciation for your work during the Health Education Labor and Pensions Committee mark-up of the of the *Every Child Achieves Act* (ECAA). We write especially to thank you for Introducing the *Empowering Parents and Students Through Information Act* (S. 528).

Your leadership and support of students with disabilities through S. 528 directly contributed to ensuring provisions were included in the ECAA requiring that states assure clear and appropriate guidelines apply for individualized education program (IEP) teams when determining that a child's significant cognitive disability justifies assessment using alternate standards. Additionally, your bill helped assure additional provisions were included in the ECAA that:

- ensure parents of students the state plans to assess using alternate assessments are involved in the decision to apply alternate standards;
- provide evidence that students with the most significant cognitive disabilities are making progress in the general curriculum for the grade in which the student is enrolled and in assessments aligned with that curriculum;
- promote the use of accommodations to increase the number of students with the most significant cognitive disabilities who are tested against grade-level academic achievement standards;
- ensure that general and special education teachers and other staff know how to administer assessments;
- require that students who take an alternate assessment are not precluded from attempting to complete the state requirements for a regular secondary school diploma.

Together, these provisions significantly protect and support the rights of students with disabilities and also reinforce research-based best practices that we know make a critical difference in students having access to the same educational opportunities as their peers. CCD appreciates your efforts to assure the outcomes of all students matter in the reauthorized ESEA.

Again, thank you for your leadership on behalf of students with disabilities and their families. We look forward to working with you as the *Every Child Achieves Act* moves forward.
