Dear Representative Stivers and Representative Beatty:

The undersigned members of the Consortium for Citizens with Disabilities (CCD) Long-Term Services & Supports (LTSS) Task Force write to express our support for the SENIOR CARE Act (HR 5429). We thank you for introducing this legislation, which would remove the upper age limit, currently age 64, for people with disabilities who wish to buy-into Medicaid. This legislation recognizes the dignity of work for all Americans, including people with disabilities, as well as the importance for people with disabilities to be independent and participate in society on their own terms.

CCD is the largest coalition of national organizations working together to advocate for federal public policy that ensures the self-determination, independence, empowerment, integration and inclusion of children and adults with disabilities in all aspects of society.

People with disabilities who wish to work should be able to do so as long as they choose without having to either sacrifice Medicaid coverage or their jobs. While Medicaid Buy-In (MBI) allows people with disabilities to work, earn a small income and to buy into the Medicaid program by paying a premium, it is currently capped for people under age 64. Removing this cap will allow people with disabilities over the age of 64 who wish to continue to contribute to society by working to do so without losing essential benefits and supports. Medicaid covers the vast majority of supports for people with disabilities in the United States. We are grateful for your championship of this issue, which will make a meaningful difference for individuals who find joy in work.

We look forward to continuing to work with to pass this critical legislation.
