Dear Chairman Tom Cole, Ranking Member Rosa DeLauro, and Committee Members,

We, the undersigned members of the Autism, Developmental Disabilities, and Family Support Task Force and fellow members of the Consortium for Constituents with Disabilities (CCD), are writing to you today to thank you for removing section 722 of the Agriculture, Rural Development, Food and Drug Administration, and Related Agencies funding bill. This provision would have prohibited the Food and Drug Administration (FDA) from banning devices or their use to the extent that they are authorized or ordered by a court and thus circumvent decades of advocacy against the use of contingent electric shock on people with disabilities.

CCD is the largest coalition of national organizations working together to advocate for federal public policy that ensures the self-determination, independence, empowerment, integration, and inclusion of children and adults with disabilities in all aspects of society. CCD members include disability professionals, national organizations, provider associations, self-advocates, and other allies of individuals with disabilities.

As members of the largest coalition of disability rights and justice organizations, ensuring the physical and psychological well-being of people with disabilities is an issue of paramount concern to us. As such, we were deeply alarmed by this provision, which would have served to insulate from FDA oversight and regulation a single facility – the Judge Rotenberg Center (JRC) – that employs painful electric shocks for the alleged purposes of behavior modification in people with disabilities. This provision would have served no purpose other than to shield one facility that designs, manufactures, and uses these devices on disabled people from FDA regulation. This practice is widely disavowed by the medical, behavioral health, disability advocacy, and developmental disability support communities and denounced by the United Nations as a violation of the Convention Against Torture.

Thank you for removing this provision and allowing the FDA to continue finalizing its rule to ban this device without any interference. We appreciate the Members who spoke out against this provision during the markup. The FDA's rule will ensure no one is further subjected to this torturous practice. We ask for your support in continuing to protect individuals with disabilities and others from this and any other inhumane treatment.
